Special Public Hearing to Fill District 27A Maryland State Delegate Vacancy

Saturday, January 3, 2026, 10:00 AM

On Saturday, January 3, 2026, at 10:00 AM, the Charles County Democratic Central Committee (CCDCC) will convene a Special Public Hearing at **3261 Old Washington Rd, Suite #2031 Waldorf, MD 20602.**

Eligibility Requirements and Instructions for Filing:

The Charles County Democratic Central Committee (CCDCC) is accepting applications for the purpose of filling the District 27A Maryland State Delegate Vacancy (Pursuant to the MD Constitution Article III, Section 9 & 13 – Filling a Legislative vacancy).

"A person is eligible to serve as a Delegate if, on the date of the election:

- 1. They are a citizen of the State of Maryland;*
- 2. They have resided in the state for at least one year immediately preceding that date; and*
- 3. If the district the candidate has been chosen to represent was established at least six months prior to the election date, the candidate must have resided in that district for the six months immediately preceding the election and must have attained the age of twenty-one years.*

In the event of a resignation by a Delegate from the county or district they were elected to represent, the Governor shall appoint a person to fill the vacancy. The appointment shall be made from among individuals whose names are submitted in writing to the Governor within thirty days of the vacancy by the Central Committee of the political party with which the vacating Delegate was affiliated at the time of their last election or appointment. The appointee must be a member of the same political party as the vacating Delegate at the time of their last election or appointment. The Governor shall make the appointment within fifteen days of receiving the submission"

- Candidates must be a registered Democrat, residing in the 27th Legislative District.
- Candidates will be called in alphabetical order and have 2 minutes to speak.
- Candidates may have no more than 2 people to speak on their behalf, 2 minutes each, no transfer of time to another speaker.

Documents received or post marked after the deadline and incomplete packets will not be considered.

- Letter of intent
- Brief biography (Include your full name, address, date of birth, etc....) **and** resume
- A copy of the applicant's voter registration card
- Applicants must provide evidence regarding their residence (e.g., current copy of utility bill)
